All metal that is held in our custody at Sharps Pixley is independently audited on a bi-annual basis by Deloitte and additionally we conduct regular internal audits.

Delivery

Upon request Sharps Pixley can arrange for fully insured shipping to selected countries allowing clients to take delivery of their precious metal.

We only offer clients the highest purity 999.9 gold bars from London Bullion Market Association (LBMA) accredited 'good delivery' refineries. Sharps Pixley gold bars are manufactured in Switzerland by Valcambi and Argor Heraeus and include certificates of authenticity.



SILVER

Sharps Pixley only offers clients the highest purity 999.0 silver bars from London Bullion Market Association (LBMA) accredited 'good delivery' refineries.

VAT-Free Silver, Platinum and Palladium

Silver, platinum and palladium may also be stored in one of our bonded warehouses exempt from Value-Added Tax. VAT does not have to be paid until you take physical possession of the metal. A minimum investment amount of £100,000 applies for this service.

1. OPEN AN ACCOUNT

Setting up an account can be completed in person, by phone or online.

2. DEDICATED RELATIONSHIP MANAGER

Once we have verified your details and opened your account, an experienced dedicated personal account manager will establish contact and introduce themselves to you. Together, you will discuss your trading objectives and vaulting requirements.

3. ORDER CONFIRMATION

When the trade has been confirmed and the prices are locked in and executed either in person, by phone or online, you will immediately receive a confirmation statement outlining the details of the transaction. This is a commitment to buy or sell and is irreversible.

4. TRANSFER OF FUNDS

The order confirmation will include the beneficiary's account details into which funds will be paid. When you buy, Sharps Pixley will be the beneficiary and we will notify you as soon as we receive funds. When you sell, you will be the beneficiary and will receive funds from Sharps Pixley within 24 hours.

5. Allocation & vaulting or delivery

Once funds have been received your metal will be allocated and segregated in your name. We will supply you with a custody statement if you have chosen our vaulting service or a delivery note if we are shipping the metal to you.

6. KEEP IN TOUCH

Your dedicated account manager will always be on hand should you wish to discuss further transactions, gain market insight, or simply review your investment performance or obtain a current valuation.


